DEADLINE FOR APPLICATIONS: 14 August 2022, including the submission of the title and abstract of the paper. This information will be made public on the website of the conference from the time of the registration. The registration may only be carried out via online registration system available on the website <u>https://conferences.flaw.uniba.sk/</u>.

DEADLINE FOR SUBMITTING A FINAL PAPER: 18 September 2022. Formal requirements of the paper and instructions for its processing will be published on the conference web site. **In the event that a person fails to submit their paper, they shall have no right to recover the conference fee.**

CONFERENCE FEE:

96,- € (including VAT) for personal participation

72,- € (including VAT) for online participation

The fee have to be paid solely by a wire transfer based on an e-invoice that will be issued upon the registration for the conference.

In the event that a person does not eventually participate in the conference, they shall have no right to recover the conference fee.

COLLECTION OF PAPERS: Reviewed collection of papers with an ISBN No. assigned to it will be produced in an electronic form and will be permanently accessible on the website of the conference and the website of the Faculty of Law at CU.
