Aims of education

The aim of this course is to focus students' attention on the specific characteristics of private law in Europe in such a way that they could understand the functioning of different legal systems and their underlying principles in private law area. Consequently, students will acquire research skills, analytical skills and problem-solving skills in the field of private law.

- Law and language in a comparative legal analysis

Finally, they identify current tendencies in the development of private law, including new business structures and digital market economy rules in global context.

Students are able to identify legal problems and to propose how to resolve them by legal means (problem-solving skills). Moreover, they are capable of using relevant databases in order to find reliable sources of information about the law (research skills). Finally, students are able to analyse a given legal problem in order to present arguments in support of a position (analytical skills).
