At FLR, we pay attention to a high degree of internationalization by building a scientific journal with an international reputation with the cooperation of foreign research centers: Department of Financial Law and National Economy of the Faculty of Law of Masaryk University in Brno; Department of Financial Law, Tax Law and Economics of the Faculty of Law at the Pavel Jozef Šafárik University in Košice.

The journal's development strategy aims to raise its scientific level, and is based on comprehensive measures consisting, on the one hand, of the introduction of modern management of the editorial process, and, on the other hand, of a well-thought-out and concrete approach journal's international promotion. We want to develop and implement new ambitious projects. This concept includes organizing an International Seminar, which is a forum for discussion and exchange of views but also identification of problems.

In the current Polish list of scientific journals of the Ministry of Science and Higher Education, FLR has been assigned 70 points. FLR is indexed in scientific databases and abstract services such as:

The purpose of the Financial Law Review's 2nd International Financial Law Seminar titled. "Finance of local government in the European Union", in addition to the scientific effect in the form of exchange of ideas, views and scientific reflection and discussion of the problems of local government finance in the European Union, is also to disseminate in the international system the achievements of Polish and European science, especially the countries of our partners, namely the Czech Republic, Slovakia and friendly scientific centers from other countries, in the field of financial law and finance of local government units. At the same time, we hope that the seminar will also become an opportunity for cooperation with other scientific centers and will enable networking of scientists from different countries.

Another important objective is to promote the Financial Law Review journal itself, published by the Centre for Local Government Law and Local Finance Law of the University of Gdańsk.
